I expressly waive any defense to enforcement of this Agreement arising from any claim of lack of consideration and understand that this Agreement constitutes a legal, valid and binding waiver of my rights and shall be enforceable against me, my spouse, family, heirs, assigns, personal representatives and estate for all purposes.

I understand that my automobile(s) and I may be photographed or filmed during the event and agree to allow the IRF, Inc. to use any photograph, video image or film likeness of me or my automobile(s)/motorcycle(s) for any legitimate purpose, including without limitation publication and program inclusion now and in the future, without financial compensation to me.
